

CCEF 2026 50/50 RULES

1. Ticket purchasers must be 18 years of age or older, and the name of a minor must not be written on the ticket. If it is determined prior to the draw that a ticket has been issued to a minor, the ticket is deemed void and the purchaser refunded. Purchase must be made in the province of Alberta.
2. Calgary Catholic Education Foundation staff, immediate family members, board members with signing authority, and immediate family are prohibited from purchasing tickets in the raffle.
3. Tickets will be available for sale online from 12:01 am MST on January 1, 2026, to 11:59 pm MST on March 2, 2026.
4. The 50/50 draw will be under the supervision of MNP Canada (auditors) and the Board of Directors of the Calgary Catholic Education Foundation. The prize will be drawn at:

5. The 50/50 Add On Draw will be held on Tuesday, March 3, 2026. Ticket sales cut-off is 11:59 pm MST on March 2, 2026.
6. Should all tickets be sold out before March 2, 2026, the 50/50 Add On Draw will be held on March 3, 2026.
7. Ticket purchase implies consent to receive communications from the Calgary Catholic Education Foundation and its affiliates from time to time until instructed otherwise.
8. The raffle draw will be conducted using an online raffle platform from Rafflebox Technologies Inc.
9. Tickets purchased online will receive an email acknowledgement of the confirmed sale along with their tickets.
10. The available ticket packages for sale are:
 - Series A: 1 ticket for \$10.00 (299 tickets printed)
 - Series B: 4 tickets for \$20.00 (39,400 tickets printed)
 - Series C: 20 tickets for \$50.00 (200,000 tickets printed)
 - Series D: 100 tickets for \$100.00 (300,000 tickets printed)A grand total of 539,699 tickets are available for sale on this license.
11. Prize must be accepted as awarded – no substitutes. All winners have 90 days from the draw date to claim their prize. The raffle will cover any costs associated with the prize delivery due to distance or unique circumstances.
12. Prize is 50% of total ticket sales up to a maximum of \$499,995 cash.
13. There is no minimum number of tickets to be sold before requesting a draw date extension or cancellation of the raffle.

14. Winner will be notified in writing, and in some cases, by telephone by a Calgary Catholic Education Foundation representative(s) of what they have won and how to claim their prize. At the completion of the draw, a complete searchable listing of all prize winners will be posted on theccef.ca
15. The 50/50 Prize will be issued by cashier cheque and presented at a ceremony on Friday, April 17, 2026, at the Catholic School Centre, 1000-5th Ave SW, Calgary, AB T2P 4T9. If a winner is unable to attend the in-person award, the cheque will be couriered to them.
16. The raffle draw will be conducted using an online raffle platform from Rafflebox Technologies Inc.
17. If a power failure or technical problem occurs with the electronic system, the draw will still occur on the date, location and time listed above. A manual draw will be based on the number of tickets printed and issued before the technical problem and will provide the accumulated cash prize.
18. Supposing a winner cannot be located after 90 days from the draw date, the prize of equivalent cash value will be donated to a charitable beneficiary approved by the Alberta Gaming Liquor and Cannabis.
19. Refunds must be requested in writing and will only be accepted up to February 27, 2026 after which time all tickets up to and including those sold on March 2, 2026 up to 11:59 pm MST will be considered eligible for the draw.
