

CCEF 2026 CASH RAFFLE RULES

AGLC # 763874

1. Ticket purchasers must be 18 years of age or older, and the name of a minor must not be written on the ticket. If it is determined prior to the draw that a ticket has been issued to a minor, the ticket is deemed void and the purchaser refunded. Purchase must be made in the province of Alberta.
2. Calgary Catholic Education Foundation staff, immediate family members, board members with signing authority, and immediate family are prohibited from purchasing tickets in the raffle.
3. Tickets will be available for sale online from 12:01 am MST on January 1, 2026, to 11:59 pm MST on February 19, 2026.
4. All Early Bird draws will be supervised by MNP LLP (auditors) and the Board of Directors of the Calgary Catholic Education Foundation. All prizes will be drawn at:

5. The Early Bird Draws will be held on:
 - Friday, January 9, 2026; ticket sales cut off is January 8, 2026, at 11:59 pm MST for one (1) prize of \$2,500 Cash
 - Friday, January 23, 2026; ticket sales cut off is January 22, 2026, at 11:59 pm MST for one (1) prize of \$2,500 Cash
 - Friday, February 6, 2026; ticket sales cut off is February 5, 2026, at 11:59 pm MST for one (1) prize of \$5,000 Cash
 - Friday, February 20, 2026; ticket sales cut off is February 19, 2026, at 11:59 pm MST for one (1) prize of \$10,000 Cash
6. The minimum number of tickets that must be sold or minimum revenue generated before the raffle is cancelled or an extension requested is any combination of the \$10 individual tickets (99 printed) and sets of 4 for \$20 (5600 printed), 20 for \$50 (16400 printed) and 100 for \$100 (30000 printed) that falls under \$100,000 in revenue or 66% of gross revenue.
7. The order in which the prizes will be awarded is from the prize of least cash value up to the prize of greatest cash value for all prizes. All Early Bird winning tickets will be re-entered for subsequent and Grand Prize Draws.
8. Should all tickets be sold out by the Early Bird cut-off date of January 8, 2026, all draws, beginning with the Early Bird Prize, will be made upon pre-approval from the AGLC on February 2, 2026, under the supervision of auditors from MNP LLP and the Board of Directors of the Calgary Catholic Education Foundation.
9. Early Bird Winning Tickets are eligible for all remaining Early Bird Draws and Grand Prize Draw.

10. Early Bird Prizes and Grand Prizes will be issued by cashier cheque and presented at a ceremony on Friday, April 17, 2026, at the Catholic School Centre, 1000-5th Ave SW, Calgary, AB T2P 4T9. If a winner is unable to attend the in-person award, the cheque will be couriered to them.
11. The raffle draws will be conducted using an online raffle platform from Rafflebox Technologies Inc.
12. If a power failure or technical problem occurs with the electronic system, the draw(s) will still occur on the dates, locations and times listed above. Manual draw(s) will be based on the number of tickets printed and issued before the technical problem and will provide the accumulated cash prize.
13. Ticket purchase implies consent to receive communications from the Calgary Catholic Education Foundation and its affiliates from time to time until instructed otherwise.
14. Tickets purchased online will receive an email acknowledgement of the confirmed sale along with their tickets.
15. Prizes must be accepted as awarded – no substitutes. All winners have 90 days from the draw date to claim their prize. The raffle will cover any costs associated with the prize delivery due to distance or unique circumstances.
16. All winners will be notified in writing, and in some cases, by telephone by a Calgary Catholic Education Foundation representative(s) of what they have won and how to claim their prize. After all draws, a complete searchable listing of all prize winners will be posted on theccef.ca
17. Supposing a winner cannot be located after 90 days from the draw date, the prize of equivalent cash value will be donated to a charitable beneficiary approved by the Alberta Gaming Liquor and Cannabis.
18. If any ticket purchased has been entered into any draw, no refund will be issued after the draw has taken place. Only tickets not entered into a draw may be refunded.
19. If a winning ticket stub has more than one name, the licensee will award the prize to the first name listed on the stub. The licensee and Alberta Gaming Liquor and Cannabis are not responsible for resolving any disputes which may arise from the different individuals.
